Series title: *Egyptologische Uitgaven* (*Egyptological Publications*), abbr. *EU* or *EgUitg*; published by the Netherlands Institute for the Near East, Leiden, and Peeters Publishers, Leuven.

The *Egyptological Publications* series presents studies on pre-modern Egypt, with a focus on history, philology and archaeology of the Pharaonic period, including Deir el-Medina studies.

Published volumes: see the NINO website, www.nino-leiden.nl/publications?dosearch=1&serie=2474. Volumes 1, 3, 4, 12, 13 are out of print and available as free pdf downloads on the NINO website. Volume 22 is out of print (not available online). In print volumes can be ordered from Peeters Publishers, Leuven.

Monographic studies or collective volumes may be suggested for publication; volumes are peer-reviewed.

Egyptological Publications volumes are usually published in softcover, 26.5 × 19.5 cm.

Information for prospective authors

Prospective authors or editors are invited to direct inquiries, or to submit proposals for consideration by the Editorial Board to NINO Publications' secretary, C.H. van Zoest, c.h.van.zoest@hum.leidenuniv.nl.

For print-only volumes in the *EU* series, the author(s) or editor(s) do not pay a fee, nor do they receive revenue. There is no additional cost for the inclusion of colour illustrations. For an Open Access (online) volume, NINO and Peeters will request a fee which is based on the number of pages. The copyright on *EU* volumes is held by NINO and Peeters.

If and when a publication proposal has been accepted by the *EU* Editorial Board, NINO and the author(s) or editor(s) enter into a mutual agreement. In lieu of a contract, NINO can issue a statement of intent to publish. NINO reserves the right to reject a final manuscript if it diverges substantially from the accepted proposal.

Conference proceedings or honorary volumes (*Festschriften*) will only be accepted if they are tightly edited thematic volumes: the contents must be related to a clearly defined theme.

We will not accept a volume that is already (largely) available in Open Access. If you wish to publish your dissertation or *Habilitationsschrift* as an *EU* volume, ensure that your university does not make its text freely available through its online repository – it is usually possible to have an embargo placed on your text awaiting print publication.

Volumes or contributions may be written in correct (UK or US) English, French, or German. If you are not a native speaker of the manuscript's language, we expect you to have your text corrected by a native speaker before submission.





Submitting a proposal to publish a volume in the *EU* series

If you wish to propose a manuscript for publication in our series, please send us the following:

1. A short abstract, max. 1 page A4. For a volume of conference proceedings, you may send the conference abstract. For a dissertation or *Habilitationschrift*, you may send the abstract prescribed by your university. Please mention the reason you wish to publish your manuscript as an *EU* volume rather than with another publisher.
2. The table of contents (or the list of contributors with the titles of their contributions). Estimate the number of pages for each chapter. Include an estimate of the number of illustrations, plates, tables and appendices.
3. A short CV of the author(s), max. 2 pages A4. For a dissertation or *Habilitationschrift*, you may send the CV or biographical note prescribed by your university.
4. For a dissertation or *Habilitationschrift*: name and contact information of your supervisor(s) and committee; information on your university's regulations with regard to its online repository.
5. For a proceedings volume: one peer review for each contribution (not anonymised).
6. Proposed date of submission of your final manuscript: for a monographic volume, not more than 12 months after acceptance; for an edited volume: not more than 18 months after acceptance.

The information provided must not diverge fundamentally from the final manuscript. Other than the order of contributions in a volume, major discrepancies from the accepted publication proposal may be reason to reject the final manuscript.

For honorary volumes (*Festschriften*) it is not necessary to include peer reviews of the contributions. The Editorial Board will base their decision on the table of contents and reserve the right to reject the final manuscript.

Peer review

Edited volumes (proceedings): the editor(s) of the volume is/are responsible for obtaining peer reviews of all contributions. The reviews are to be submitted alongside the proposal. If the Editorial Board requires revisions to (a) contribution(s), please anonymise any remarks before sending them to the contributor(s).

Monographic volumes will be peer-reviewed through the Editorial Board of the *EU* series.

Submitting a manuscript for publication in the *EU* series

If your publication proposal has been accepted by the Editorial Board, we expect to receive your final manuscript on or before the agreed date, including all agreed revisions (if applicable).

Elements of a volume

Please send the following elements as separate documents – each chapter, appendix, index etc. is a separate Word document. Tables are preferably one Word or Excel file. All elements will be merged by the publisher:

- title page information: title, subtitle, name(s) of the author(s) or editor(s);
- optional: frontispiece image, including caption;
- table of contents, without page numbers;
- optional: introduction or preface;
- chapters or contributions;
- optional: figures, small graphs, small tables – to appear as illustrations in the text;
- optional: plates, maps, larger graphs, larger tables, appendices, catalogue – to appear after the last chapter or contribution;
- list of all illustrations, plates, tables etc. and their captions;
- optional: list of abbreviations used;
- recommended: bibliography or list of references;
- recommended: indices.



Copyright permissions for illustrations must be obtained by the author or editor prior to submission of the manuscript.

When the final manuscript has been accepted by the Editorial Board and sent to the publisher for formatting, we will ask the author(s) or editor(s) to provide

- an image to be used on the cover (required; may well be one of the illustrations in the volume);
- a blurb text to be used on the back cover and in online announcements (in the volume's main language; 200 to 300 words).

Style guidelines

Formatting will be done by the publisher, so send your manuscript in the simplest of layouts. Do indicate headings and subheadings; these will be typeset in our standard format: **HEADING LEVEL ONE (SMALL CAPS)** – **Heading level two (bold)** – *Heading level three (italics)*.

For bibliographical references, use one style throughout the volume. We recommend following the bibliographical reference style of the *Journal of Egyptian Archaeology*, including its standard abbreviations of journal and series titles. However, we prefer page numbers in references to be written in full (132-136; not 132-6).

Use footnotes, not endnotes.

For (parts of) texts containing transliterations, non-standard fonts and/or diacritics, it is recommended to send both a text file and a pdf file – the latter will serve as an aid to correct formatting by the publisher.

Do not paste illustrations in your text. Either indicate where an illustration should be inserted, or highlight the first reference to every illustration. Send the illustrations as separate image files (jpg, tiff, pdf) in the highest available resolution. Illustrations may either be numbered per chapter/contribution, or consecutively throughout the volume. Image files should have a file name that includes its number. Provide a list of all illustrations in the volume complete with captions.

The same is applicable to plates, larger maps, larger graphs etc. that will appear after the main text of the volume: do not paste images in a text file, but send separate files, clearly named, and provide a list complete with captions.

Any illustrations, plates, graphs, tables etc. containing text are preferably sent in editable format (e.g. Adobe Illustrator, Excel). This will allow setting text in the same font as the main text, making small adjustments to the arrangement of images within a plate, bringing uniformity to illustrations from different sources, etc.

Edited volumes: one bibliography or list of references is preferred over separate bibliographies with each contribution.
